- Developed a College of International Studies Research Support Council to award internal College research funds to faculty and to support faculty grant efforts internal and external to OU.
- Led the development of a new online MA in Global Affairs program; wrote program proposal for submission and approval by State Regents; developed curriculum; structured and led faculty development program. Initiated in fall 2015, the program reached enrollment of 125 students in 2022. Expanded access to a quality online degree while raising more than \$1 million in tuition revenue during fiscal year 2022.

Book Projects in Progress:

Who Speaks for Europe?

There is a fundamental disjuncture in Europe between the means of integration and the means of socialization. What are the consequences for the integration project? How have EU institutions addressed this challenge? Where have they failed? How might they be more successful?

The Great Perceptual Divide

Drawing on literature in social psychology, the book examines the deep political gulf in the US and a similar divide in the UK over British exit from the European Union. To what extent do perceptions converge as additional information – about the costs of British exit, for example – becomes available? If perceptions do not converge, why not? What are the consequences for democracy?

<u>Iournal Submissions in Progress:</u>

"From National to European Socialization: The House of European History and Integration as an Organic Process"

Based on extensive study of the exhibits at the House of European History established in Brussels by the European Parliament, the article identifies a narrative of integration as an organic process in which borders are unnatural, porous and fluid; when borders defy these characteristics and there are political efforts to render national demarcations more fixed and rigid, destructive conflict ensues.

"The Rise of Regulatory Populism" (Accepted for presentation at the September 2020 Conference of the University Association on Contemporary European Studies, Belfast)

EU regulation is vulnerable to local media and political criticism focused on costs because regulations are designed to produce public goods, such as reduced electronic waste and protection of biodiversity rather than benefits highly visible to individuals. Can "regulatory populism" — characterized by measures like "roam like at home" (ending international roaming charges) and the "right to repair" (ensuring parts are available to repair heavy appliances) transcend local socialization effects?
